**Past Meeting Notes**—June meeting notes were approved.

**Tournament Report**—Mixer with the Women's club was June 29<sup>th</sup>. Feedback indicates it was successful.

Match play is progressing with the loser brackets a little behind; one winner's bracket match is behind schedule.

**Mountain Classic Report**—Breakfast will still be provided however with a different menu. It will now be a grab and go out of the snack bar.
